- Liaison positions expectations are discussed, and members proposed their candidature for some open positions.

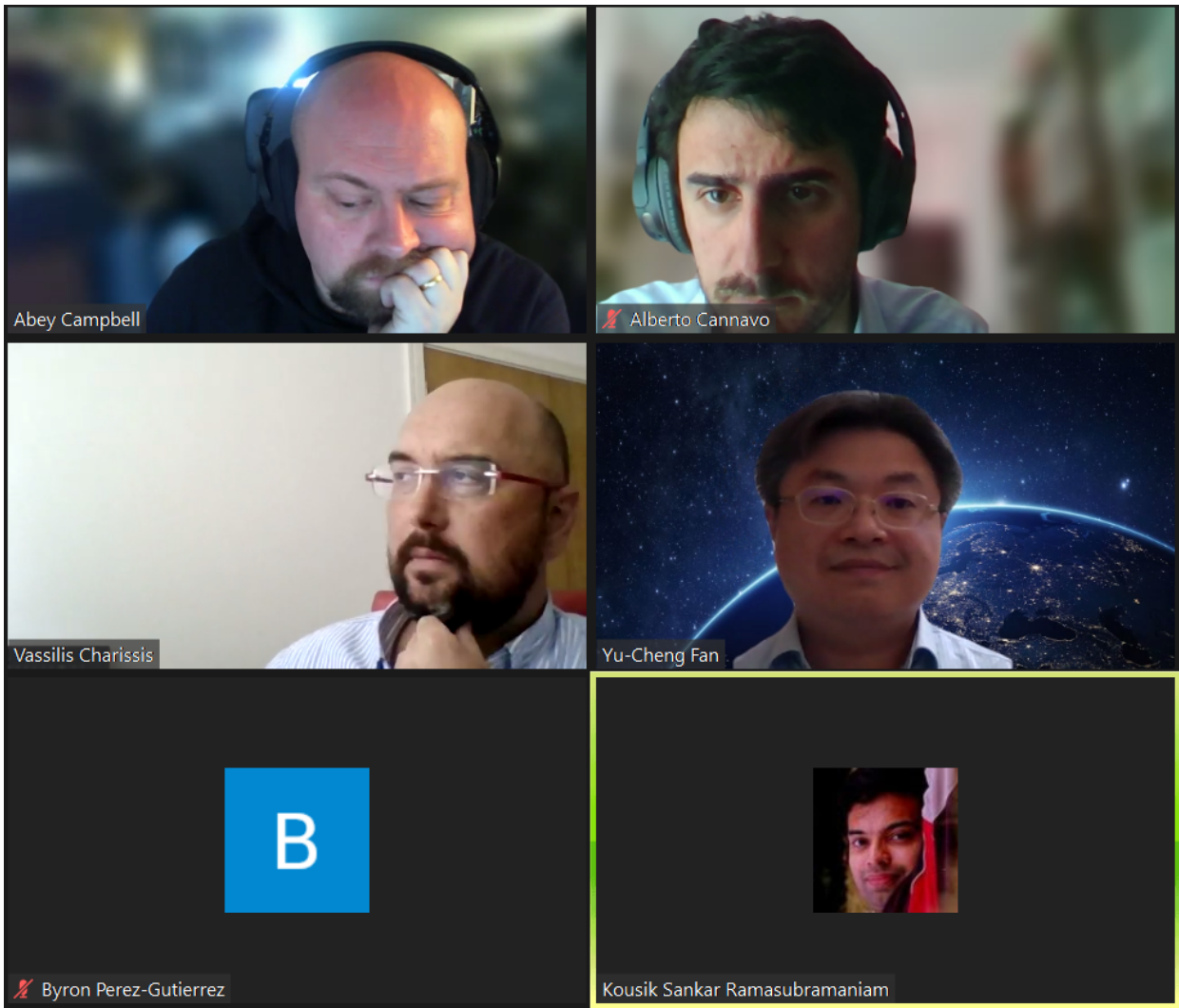


Fig. 1 – A screenshot of the meeting that took place on 19 April, 2022

Technical Activities P&Ps

- The responsibilities of the Technical Committees, Technical Committees Board, FDC and the VP of Technical Activities are included in the new version of the CTsoc Bylaws and Constitution
- Detailed **Policies and Procedures (P&Ps)** are illustrated in the section of CTsoc Operations Manual devoted to Technical Activities, motion passed on BoG meeting January 29-30, 2021

1.1. Technical Activities

Technical activities in the fields of interest of CTsoc are promoted through Technical Committees. All Technical Committees report to the VP of Technical Activities and to the Technical Committees Board. Besides Technical Committees, also the Future Directions Committee (FDC) reports to the VP of Technical Activities.

1.1.1. Technical Committees Board

1.1.1.1. Scope and Objectives

The Technical Committees Board is the supervisory group for the Technical Committees and shall also support organization, quality control, and management of CTsoc's technical activities. The Board shall:

- Ensure Technical Committees are covering topics that are timely and of interest to CTsoc, by possibly suggesting the creation of new Technical Committees and deciding on creating/merging/modifying/dissolving existing ones.
- Ensure Technical Committees are operating per the CTsoc's Bylaws and Constitution, as well as per the Technical Committees' Policies and Procedures (P&Ps), addressing any generated conflicts.
- Encourage CTsoc's members to propose new Technical Committees on timely topics.
- Encourage the participation of Technical Committees in CTsoc's products, including the organization of conferences, the identification of feature topics for publications, the involvement in standardization activities, the support in raising awareness about the history of consumer electronics, etc.
- Address issues that could emerge amongst officers and members of a Technical Committee.

1.1.1.2. Organizational Structure

The Technical Committees Board reports to BoG. The Board is chaired by the VP of Technical Activities and consist of:

- Chairs of Technical Committees
- VP of Conferences
- VP of Publications
- VP of Industry and Standards Activities
- CTsoc President as Ex-Officio member

The Chair can appoint a Board Vice-Chair chosen among the Board members who assist the Chair and acts on behalf of the Chair in the event of his/her incapacity.

1.1.1.3. Transaction of Business

All Board business shall be conducted in compliance with CTsoc's Bylaws and Constitution.

The Board shall have biennial meetings to discuss the status of the activities of the Technical Committees and other technical endeavors within the CTsoc's field of interest.

The Board shall hold at least two in-person regular meetings per year, one around January at ICCE flagship conference, one combined with a CTsoc's event around June (with the possibility of remote participation by dial-in). The other meetings (in-person or by teleconference) will be called on a periodic basis.

1.1.1.4. Approval of Technical Committee's P&Ps

The P&Ps of each Technical Committee require the approval of the Technical Committee Board before taking effect.

The process for submitting Technical Committee's P&Ps (and their amendments) for approval shall be as follows:

1. The Technical Committee shall first approve its P&Ps (or the amendment).
2. The Technical Committee Chair shall forward the approved P&Ps to the Technical Committee Board Chair, who shall schedule their discussion in the next Technical Committee Board meeting.

Technical Committees

- New Technical Committees can be proposed (e.g., by CTSoc members), and existing Technical Committees may be merged, modified, or dissolved as necessary to ensure continued relevance and effectiveness
- Technical Committees may form Subcommittees and Special Interest Groups (SIGs)
- Each Technical Committee will have a **dedicated page on CTSoc website**, with information about officers, scope, P&Ps, membership information, and minutes of meetings held

Technical Committees

- Objectives (detailed in the P&Ps)
 - Support CTSoc’s technical activities in the areas of **conferences, publications, standards, and education, and history**
 - Investigate, evaluate, promulgate and foster current and emerging technologies and applications of interest to CTSoc
 - Create additional Technical Committees for technologies of interest to CTSoc and conduct periodic and special technical meetings as directed by the BoG
 - Support development of new cross-cutting initiatives in collaboration with other Technical Committees of CTSoc, and, as appropriate, with other IEEE Society/Council Technical Committees and IEEE organizational units
 - Define new areas of technology focus and encourage formation of new initiatives through the CTSoc’s Future Directions Committee (FDC)

Technical Committees

- Objectives (**for conferences, see also present. by VP Publications**)
 - Invite qualified individuals from both industry and academia to consider joining the Technical Committees
 - Review and approve – as recommendations for approval by the SCSC and then BoG – the Call for Papers (CFP) of conferences
 - Support conferences by contributing papers and providing reviewers
 - Provide publicity for submission of papers and other participation in conferences
 - Recommend conferences' Technical Program Committee Chair(s)
 - Provide conference Track and Session Chairs
 - Collect proposals for the hosting of conferences as well as for academic and industry conference speakers

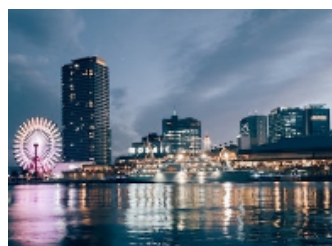

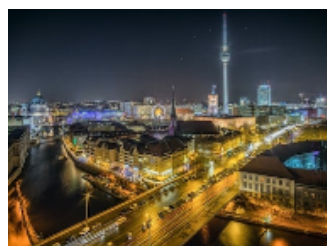

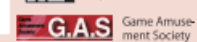
